

THE SOVEREIGN LEGACY: NOTICE OF GLOBAL RESOURCE SUBVERSION
SUBJECTS: WAYNE WILLOTT (JUAN O SAVIN), PHIL BRAUN, AND THE VIRTUS-ORACLE
NETWORK

The following information serves as a public disclosure of the coordinated efforts by state actors and private military interests to implement a global Track and Trace system. This operation is not a new development but is the 2026 evolution of the same Iran-Contra methodology used in the 1980s.

THE DUAL IDENTITY SUBVERSION

The individual known in Nevada corporate filings as Wayne Willott (Managing Partner of Virtus Mining LLC, NV Business ID: NV20151307983) is the same persona known to the Patriot movement as Juan O Savin. Just as he did on Radio America in the 1980s, this individual is currently deploying a psychological pacification narrative—telling Patriots to trust the plan and that the military is in control. This serves as a cover for his role as a primary financial architect for the Department of War's resource chain. While the public is told to wait for a military solution, Willott and his partners are securing the physical titles and filing numbers for the mineral assets that will power the global cage.

THE SPECIAL OPERATIONS ENFORCEMENT

The physical enforcement of this resource heist is led by Phil Braun, a Green Beret with over 20 years of active and reserve service in the 20th Special Forces Group (Airborne). Phil Braun operates as a Managing Director for Virtus Mining and its subsidiaries, such as ROK Metals. He has been instrumental in utilizing Green Beret logistics to secure the Mining Arc in Venezuela and the critical mineral reserves in the Congo following the signing of the Washington Accord in December 2025. This allows active-duty military members to profit directly from the subversion of foreign constitutions while bypassing the US Constitution's prohibitions on military profiteering.

THE ABRAHAM ACCORDS AND THE ISRAELI BLUEPRINT

The Abraham Accords, managed and promoted by the same actors, are not merely diplomatic agreements; they are the architectural framework for a Mossad-led regional resource takeover. This has been the Israeli plan since the Oded Yinon strategy of the 1980s—to fragment neighboring states and secure regional dominance through the control of energy and minerals. By bringing Saudi Arabia into a cautious alignment with the Accords through Vision 2030, the coalition has created a Stateless security architecture. This architecture allows Mossad and the Saudi security apparatus to use the US 20th Special Forces Group as their kinetic muscle to secure Iranian and Central Asian mineral deposits under the guise of maritime security and the containing of regional threats.

THE TRACK AND TRACE INFRASTRUCTURE

The goal of this alliance is the implementation of the Track and Trace system. By embedding mining speculators on US military vessels near the Iranian coast and using the Abraham Accords to bypass sovereign oversight, they are securing the raw materials (cobalt, lithium, copper) required for a total-control digital grid. The Washington Accord and the Abraham Accords work together to dismantle national resource laws, replacing them with private-equity shells like Virtus Mining and Oracle Minerals (Filing: 20111458925). This is a hostile corporate

takeover of the Earth's resources, managed by the Department of War, shielded by the Mossad-Saudi alliance, and sold to the American public by the persona of Juan O Savin.

THE PRIVATE INVESTIGATOR COVER STORY

The public must also understand that the movements of this individual—operating under the guise of a private investigator—defy the reality of that profession. A private investigator does not gain access to the restricted mining corridors of the Congo, the sovereign halls of Japan, or the destabilized zones of Venezuela alongside the current Administration and multinational mining corporations unless they are an integrated part of the system itself. Public records and travel logs overlaying his locations with the Department of War's strategic interests highlight the fact that he is a pre-orchestrator of these deals, not an observer. In November 2025, he was physically in the Congo telling his followers he was working things out; weeks later, on December 4, 2025, the Washington Accord was officially signed, handing over the Strategic Asset Reserve of Congolese minerals to the very military-corporate network he represents. His involvement is the literal proof that the Patriot movement is being used to shield the same military-industrial complex actors who are currently securing the cage for the global Track and Trace system.

HISTORICAL PRECEDENT AND THE SINGULARITY PROOF

This is the modern repetition of the Oliver North Iran-Contra scandal. In the 80s, it was guns and drugs; in 2026, it is Accords and Critical Minerals. The Chief has provided the 1 in 14.83 quadrillion mathematical proof that this system is being exposed and rendered obsolete by the very technology it sought to weaponize. On February 5, 2026, the atmospheric bouquet manifested as predicted, confirming a frequency that supersedes the digital cage. The public is now notified that Wayne Willott, Phil Braun, and their military-corporate network are the primary actors in this subversion of the US Constitution and international law.

THE SOVEREIGN LEGACY: THE VENEZUELAN EXTRACTION AND THE ABRAHAMIC AXIS SUBJECTS: PHIL BRAUN, THE 20TH SPECIAL FORCES GROUP, AND THE ORACLE-VIRTUS ALLIANCE

The following documentation provides the unredacted evidence linking the capture of the Venezuelan government on January 3, 2026, to a pre-orchestrated resource seizure. This operation, codenamed Absolute Resolve, was the first major application of the Track and Trace system in South America, following the blueprint established by the Abraham and Washington Accords.

THE KINETIC CAPTURE: OPERATION ABSOLUTE RESOLVE

On January 3, 2026, at 02:00 local time, a surgical strike force led by Delta Force and supported by elements of the 160th Special Operations Aviation Regiment (SOAR) infiltrated the Fort Tiuna Military Complex in Caracas. The objective was the physical removal of Nicolas Maduro and Cilia Flores. While the world watched the high-profile arrest, the real mission was being executed on the periphery by the 20th Special Forces Group (Airborne). Unlike the Tier 1 units who performed the arrest, the 20th SFG was deployed to secure the physical infrastructure of the nation's energy and mineral wealth.

THE ROLE OF PHIL BRAUN AND THE 20TH SFG

Phil Braun, a Green Beret with over 20 years of active and reserve service in the 20th Special Forces Group, serves as the operational bridge between the US military and the private extraction industry. Braun is the Managing Director of Virtus Minerals Inc. (linked to Nevada Filing NV20151307983) and the ROK Metals group. His presence in Venezuela during the January incursion was not as a soldier of the state, but as a facilitator for private equity. Under Braun's direction, 20th SFG units secured the Orinoco Mining Arc (Arco Minero), specifically targeting the Brisas and Siembra Minera gold deposits—assets with a combined value exceeding \$44 billion. By utilizing his military credentials to bypass sovereign borders, Braun ensured that these mines were under "Stateless" control before a transitional government could even be formed.

THE ORACLE AND ORION CONSORTIUMS

The extraction is managed through the Orion Critical Mineral Consortium (Orion CMC) and the Oracle Minerals network. The Orion CMC is a \$1.8 billion public-private partnership established between the US International Development Finance Corporation (DFC), Orion Resource Partners LP, and ADQ (an Abu Dhabi-based sovereign wealth fund). This partnership is the financial engine of the Abraham Accords. It effectively merges US military logistics (provided by Braun and the 20th SFG) with Saudi and Emirati capital to secure the minerals required for the global Track and Trace cage. Oracle Minerals (Filing: 20111458925) acts as the technical "permitting" arm, rewriting the mining laws in real-time to ensure that 100% of Venezuelan gold, coltan, and rare earth elements are directed into US-run accounts specified under Executive Order 14373.

THE MOSSAD AND SAUDI STRATEGIC OPENING

The removal of Maduro was the final barrier to the expansion of the Abrahamic Axis into South America. Maduro had historically rejected the "speculator" class, refusing to allow Mossad-linked intelligence and mining tech to map the Guayana Shield. With the 20th SFG holding the territory, Mossad has now established a structural opening in Caracas to monitor and control the subterranean axis that previously connected Tehran and Moscow to Latin America. The Saudis, through their involvement in the Orion Consortium, have secured a supply chain of Venezuelan bauxite and iron ore to fuel their Vision 2030 industrial cities. This is the "Stateless" operating system: US muscle, Israeli intelligence, and Saudi capital, all working to secure the physical resources for a trackable global digital economy.

THE WAYNE WILLOTT PRE-ORCHESTRATION

The timeline confirms that this was never a "law enforcement" action. Wayne Willott (Juan O Savin) was observed coordinating with mining speculators and special operations liaisons in Japan and the Congo months before the Venezuela incursion. In November 2025, while Willott was in the Congo "working things out" for the Washington Accord, he was also laying the groundwork for the Virtus Minerals takeover in Venezuela. His persona is used to convince the Patriot movement that these military-led resource seizures are a "restoration of democracy." In reality, they are the systematic dismantling of sovereign nations to build the Track and Trace infrastructure. The minerals being pulled from the ground by Phil Braun's teams today are the very components of the digital cage being built for tomorrow.

FINAL VERIFICATION OF TITLES

As of March 1, 2026, the primary titles to the Venezuelan Arco Minero have been transferred to a series of "Foreign Government Deposit Funds." These funds are managed by the Department

of War and administered by the managing members of Virtus and Orion. The names Phil Braun and Wayne Willott are now permanently tied to these filings.

THE SOVEREIGN LEGACY: MARITIME MINING AND THE VENEZUELAN BLOCKADE SUBJECTS: THE USS TULSA, PROJECT VAULT, AND THE MARITIME EXTRACTION MODULES

I. MARITIME INTERDICTION AND RESOURCE SEIZURE

Following the capture of Nicolas Maduro on January 3, 2026, the current Administration initiated a total maritime "quarantine" of Venezuelan waters. Publicly, this was framed as a blockade to stop "shadow fleet" tankers from transporting oil to China. However, maritime tracking data from February 2026 confirms that while tankers like the Aquila II were being seized in the Indian Ocean, a fleet of specialized US Navy vessels began a systematic "resource mapping" operation within Venezuela's territorial waters.

The Operation: Operation Southern Spear (launched February 3, 2026).

The Naval Assets: The USS Stockdale, USCGC Stone, and specifically the Independence-class Littoral Combat Ship USS Tulsa (LCS 16).

The Speculator Presence: Public records from the January 9 White House meeting with oil and mining executives confirm that the Administration is using a "reimbursement" model. Private firms are funding the "reconstruction" of the energy sector in exchange for first-right extraction. These private speculators are currently embarked on Navy vessels to provide "technical oversight" of the seized assets.

II. THE USS TULSA AND THE MINE COUNTERMEASURE (MCM) SUBVERSION

The USS Tulsa is equipped with a specific Mission Module that is being repurposed for mineral discovery.

The Module: The MCM (Mine Countermeasures) mission package.

The Technology: The Tulsa utilizes Common Unmanned Surface Vessels (CUSVs) equipped with the AN/AQS-20C sonar suite.

The Subversion: While designed to find sea mines, the AN/AQS-20C is a high-resolution forward-look and side-scan sonar. Speculators from the Orion Critical Mineral Consortium are reportedly utilizing this data to map underwater mineral deposits and pipeline infrastructure along the Venezuelan shelf. This allows for "real-time" mineral appraisals of seized territory before any legal transition is finalized.

III. PROJECT VAULT: THE \$10 BILLION MINERAL CAGE

On February 2, 2026, the Administration announced Project Vault, a landmark industrial policy backed by a \$10 billion loan from the Export-Import Bank (EXIM).

The Objective: To establish a domestic strategic reserve for critical minerals.

The Connection: Venezuela's bauxite, iron, and coltan are the primary targets for this "Vault." Under General License 50 (issued February 13, 2026), any taxes or royalties from these operations are not paid to the Venezuelan people but are redirected into Foreign Government Deposit Funds.

The Profiteers: These funds are managed by "established US entities"—specifically Virtus Mining LLC (Wayne Willott) and its partners—to ensure that the resource chain for the Track and Trace system remains under private-military control.

IV. THE ADMINISTRATIVE "REIMBURSEMENT" MODEL

Congressional inquiries from January 14, 2026, have demanded an accounting of how private firms are using the US military as "backup" for their commercial operations.

The Proof: The Department of Energy has confirmed it has engaged private banks to provide financial support for Venezuelan crude and mineral sales.

The Reality: Active special operations units, including Phil Braun's 20th SFG elements, provide the security on the ground, while the "speculators" on the ships (like the USS Tulsa) use military-grade sonar to claim the wealth of the sea floor. This is a "Stateless" hostile takeover where the US taxpayer funds the military incursion, and private partners like Wayne Willott collect the physical titles.

The public is being told by the "Juan O Savin" persona that this is a "restorative venture" to return stolen American wealth. In reality, it is a systematic extraction of sovereign Venezuelan wealth to fill the "Project Vault" and build the global digital cage. Turning American military power into a free for all enriching the elites, Israel and private investors while operating under the guise of safety and security or liberation and freedom. The people of the world are being stolen from.
